Good morning Kirstie,

Due to other commitments I cannot get to the quarry site today. However Tony Dopson (07899 920217). We have been testing materials since the job started and have on occasions made Bly increase excavation to deal with the contamination by the industrial estate when our results were not satisfactory.

We also check the stockpiles of clean soils currently not being used.

I have seen the nonsense in the local rag totally malicious, technically silly but I suppose useful for the cats tray.

The soil has been somewhat wet from day 1 and the issue of dust (the only route other than skin contact) has been a fleeting dream. All site staff wear gloves which mitigates the skin contact. As the soils are being dug by machine actual human contact is minimal. After the contaminated has been removed there is no need for anything but normal PPE (gloves) to protect from Weils disease. At present the contaminated soil is stored on plastic sheet. The volatiles are practically iinsoluble but can be improved by aeration when the weather improves.

Tony will show you the emergency PPE that is kept on site. We carry far more in our vehicles of course.

The newspaper article reflects observations by someone not aware of what is actually being carried out.

I suggest I pop over to see you at your office with the records next week or we meet on site. I am tied up this week with a diesel and flooding problem with a risk to a grade 1 waterway so I cannot get to the site.
